Whereas, the UG & PG Departments aim to promote research, knowledge, and academic growth amongst its students, faculty and community and the Government College for Women strives to provide access to knowledge, resources, and infrastructural facilities.

Both institutions acknowledge the mutual benefits and advantages of establishing a collaborative relationship to enhance research and academic development. Therefore, jointly the UG & PG Departments of Government College Nalwa and the Government College for Women agree to terms and conditions of the MOU.


(c) Areas of Collaboration: Both the institutions mutually agree to collaborate in the following areas:

- i) **Sharing of Resources:** Both the colleges will provide access to its educational materials to the college students for academic and research purposes.
- ii) **Training and Workshops:** Both the colleges will organize training sessions and workshops for faculty and students of the college.
- iii) **Joint Projects:** The institutions will explore opportunities for joint research, knowledge sharing initiatives, and collaborative projects that align with their respective objectives and promote academic excellence.
- iv) **Faculty Exchange:** The faculty member of one institution will be invited by the other institution to give lectures, present at conferences, perform services, or contribute in other ways to the benefit of the inviting institution.
- v) **Student exchange:** The institutions will exchange students for research and study and for exchange of research and educational materials, publications and academic information.
- vi) **Exchange programs:** The colleges will establish certain exchange programs beneficial to the respective educational institutions and to promote the development of joint studies, research and training activities and other educational exchanges of mutual interest.
- vii) **Joint research activities:** Organization and participation in seminars, symposia, short-term academic programs and academic meetings.

(d) Responsibilities of the Colleges:


- 1) The colleges shall assign a designated liaison to coordinate and facilitate communication between the institutions.
- 2) The colleges shall ensure the respectful and proper use of college resources and comply with the college rules and regulations.
- 3) The colleges shall organize training sessions, workshops and other knowledge-sharing initiatives for the faculty and students of the college


- 4) The colleges shall actively participate in the training sessions, workshops and joint projects organized by the college.
- 5) The colleges shall provide access to its educational resources to the faculty and students of the college.
- (f) **Confidentiality:** Both parties agree to maintain the confidentiality of any proprietary or sensitive information exchanged during the course of this collaboration.
- (g) **Duration and Termination:** This MOU shall commence from the date of signature by the authorities of both the institutions and shall remain in effect for a period of five years initially and subject to renewal in future. Either Institution may terminate this MOU by providing written notice to the other with an advance notice.

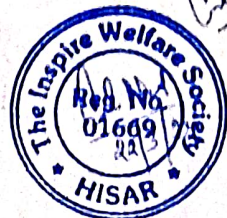
